

## **SAVING OUR PRECIOUS CONSTITUTIONAL REPUBLIC**

The right to vote in a free and fair election is the most basic civil right, one on which many of the other rights of the American people depend.

As long as elections put people into positions where they can make decisions about how much the government will spend, who will receive benefits, and how the government will exercise its power, some people will attempt to cheat.

States have the right and responsibility to ensure the integrity of their elections and to ensure that the votes of eligible voters are not stolen or diluted by fraud. Some states have taken action to make voting easier and cheating harder. The Nevada legislature needs to take action to reverse recent voting legislation.

Recently, Nevada joined eight other states in making universal mail-in balloting legal. This was done on a party-line vote in the legislature and over the objection of Republican Secretary of State Barbara Cegavske. One other notable provision in this Nevada law is that it allows third parties to collect and hand in ballots on voters' behalf, a practice detractors call "ballot harvesting."

The other eight states that have passed these laws have gone from red states to purple and now blue states. Nothing is more important to Republicans in the upcoming Nevada legislature than reversing this practice. There is hope. Governor Lombardo has committed to reversing this fraud-inducing practice.

Besides ridding ourselves of Universal Mail-in Ballots and Ballot Harvesting, the Heritage Foundation said we need to:

- Require all voters to present photographic identification, issued by the federal, state, or local government, when they vote at their polling place and to send copies of such identification or their driver's license number when submitting an absentee ballot.
- Require all individuals who register to vote to provide documentation establishing that they are U.S. citizens.
- Require state and local election officials to verify the accuracy of new voter registration information against other available state and federal databases.
- Reject any effort to get rid of the Electoral College. Any state compact to manipulate or alter the Electoral College requires congressional assent. Such a compact should not be approved, and any constitutional amendment to scrap the Electoral College should be rejected.

Some Republicans now advocate that rather than fight to clean up voter integrity laws, we should learn to play the Democrat game and engage in ballot harvesting. My view is that we will never be as good at this as Democrats and it is a losing strategy.

Reversing these disastrous state laws should be priority one for every Republican who wants to preserve our Republic and make Nevada red again. We should join Governor Lombardo and make ballot harvesting illegal again along with other voter integrity improvements.

Support Senate Bill NO. 405 introduced on March 27, 2023, which addresses these problems. The bill is sponsored by the Senate Committee on Legislative Operations and Elections. Members of this committee are Senators Ohrenschall (D-Chair), Daly (D-Vice Chair), Cannizzaro (D), Gansert (R), Krasner (R).

Call all representatives and write letters to them, copying the Governor, as this bill is essential to fair elections and should do what Governor DeSantis did in Florida to make voting easier and cheating harder.

## **NvFRW Southern Leadership Workshop Report**

**NvFRW's Southern Leadership Workshop** was held on March 2, 2023 at the Hilton Garden Inn Las Vegas. MRW members Sue Smith, Lizz Wells, Sue Zarubin, Carol Shepherd, Patty Shelato and Linda Shannon attended the workshop in order to hone skills for effective Republican leadership.

**NvFRW President Caroline Smith** kicked off the meeting by announcing the national NFRW Convention will be held in Oklahoma City, OK on September 28-30; and the state NvFRW Convention will be held in Reno on October 20-21, 2023. Eight voting delegates from Nevada will go to the national convention. All members are welcome to attend any conventions.

Nevada's U.S. Presidential Preference Poll will be held on February 6, 2024.

**Leadership Chair Phyllis Westrup** advised that we read our local, state and national federation bylaws to be familiar with them. Open communication with members and board is critical, and that includes listening as well as speaking. Consistent inspiration, respect for all and team-building are key attributes to build upon. When debate occurs, we must focus on issues, not personalities. Vision and leading by example will unite people peacefully.

**Mary Beganyi, Southern Regents Committee Director**, encouraged us to become Regents to support NvFRW's educational goals. The Regents underwrite the Leadership Trainings, which are free to all participants.

Capitol Connection, published via email by NFRW, was lauded as a good source of information, and also Bite Size Tools, NFRW zoom virtual training events on the last Tuesday of each month.

**Parliamentary Procedure** was reviewed by **NvFRW's Parliamentarian Connie Skidmore**. She reminded us to ensure that our Bylaws are current and in compliance with NvFRW and NFRW Bylaws. The best sequence for a decision is for a member to make a motion, with discussion to follow. Example: "I move that we have two fundraisers for the year." After a second, the idea is discussed. Then there is a call for the question; and the vote is taken.

There were about six breakout groups based on functions of officers or committees: President, Programs, Membership, Treasurer, Secretary, etc. followed by a very nice hot chicken buffet lunch with many sides and desserts.

**Pauline Lee** was the featured speaker. She has a law degree from Duke University and was head of the Nevada Republican Club with 550 members. She was part of Governor Lombardo's transition team. Her recommendations are as follows:

We need to let our elected officials know of our objections to horrible bills. SB60 and SB142 are a few that would eliminate paper ballots, extend the counting of ballots to 9 from 7 days after election day, and establish a homeless bill of rights including voting (but not counseling).

We need to take abortion off the table from the democrats as a rallying cry. She suggested a 24-week rule as something we Republicans should try to live with. SB131 is related to this issue: it basically says that we won't enforce other states' laws outlawing abortions. Governor Lombardo may even support this. Pauline believes, however, that this bill is unconstitutional according to Article 4, Section 1.

There is a transgender surgery bill that would require the state to pay. Governor Lombardo will veto bad bills, but we need to ensure that not one Republican sides with Democrats, or the veto can be over-ridden. Stay in touch with our Republican representatives. Contact the Democrats with our opposition as well.

She emphasized how important it is for us to recruit great candidates with a track record of working on community issues, like Manny Katz for example. We need good female candidates, too! We support our young women. She advised us to get back on Twitter so that our conservative opinions are in the conversation. Otherwise, we won't be heard. We are in an ongoing war.

We need to stop being election deniers and polish up our tarnished Republican brand, in her opinion.

Pauline recommended light ballot harvesting at centers for the blind; Hope for Prisoners; and Vegas Stronger. Since it is still legal, we need to take advantage of this. Adopt a charitable non-profit, like our SafeNest and Mesquite Community Education Foundation. Provide services to business, such as a luncheon to help voters complete their ballots by providing slate cards. The unions do this now. Incremental changes are needed, like Harry Reid did. Lombardo Inc. is coming! Governor Lombardo wants to be very involved in vetting state candidates who are probusiness, pro-family, and pro- education. He is pro-school choice.

**Caroline Smith** ended the training by announcing that Nevada won national awards for the greatest number of phone calls the last half of 2022; and we were in the top five states for the greatest number of renewals. If a dollar value were figured for all calls made nationwide, it would be equivalent to about \$140 million. These figures prove that women have great relevancy to Republican campaigns nationally.



## BACK TO BASICS IN THE NFRW

## Membership

When does a prospective member become a member of the NFRW? Is she an NFRW member when she pays her dues to your local clubs?

No – she is a member of the NFRW only when the following steps are completed:

- The club forwards her name, address, etc. as well as her national dues to the state federation;
- The state federation adds her name and personal/membership information to the national database; AND;
- The state federation generates an invoice with her name on it; AND
- The state federation sends the dues to the NFRW by check or credit card; AND.
- Finally, when the NFRW receives the payment and posts it to the database,

Then your prospective member is a member of the NFRW.

So if your club doesn't report her membership and forward her dues when she joins, she cannot receive the benefits of being a member of NFRW:

- She doesn't have a member ID since that is a function of the database;
- She can't access the NFRW website without a member ID;
- She doesn't receive the Capital Connection or MAGA Alerts or any other email notices from the NFRW as the email list comes from the database.
- She can't attend state or national board meetings as a member.
- She can't be a delegate or alternate at state or national conventions. And can't vote.

## Dues

Annually what are the NFRW membership dates? The NFRW bylaws specifically say that the calendar year is the fiscal year and all memberships are from January 1 through December 31.

Section 5. Fiscal Year:

- A. The fiscal year of the NFRW shall be from January 1 through December 31.
- B. The fiscal year of each state federation and local club shall be from January 1 through December 31.



## **NFRW Membership Tools**

## What Services Do Your National Dues Provide?

The National Federation of Republican Women has one of the lowest membership fees in the country – just \$20.00 annually per member. For this nominal fee, members receive a variety of services and access to political activities and information.

For just \$20.00 in annual national dues, a member receives or has access to:

- A robust national website and member database management system that connects the entire Federation and provides key membership services, including administrative access and capabilities at the club level.
- The NFRW's electronic communications, including the weekly and monthly newsletters and political briefings, and free or nominally-priced publications like the Leader's Guide, Membership Handbook, Legislative Advocacy Manual, and outreach/recruitment materials.
- The Member Center, a private online network on the NFRW web site available to members only. The Member Center includes a member directory and the Digital Resource Library, which features committee and issue-related resources and materials, general organizational publications and forms, event information, graphics, and more.
- Assistance in creating new clubs, launching or updating a state or club web site, and other membership services.
- Sample materials, multimedia and resources that assist states and clubs with public relations and fundraising efforts, membership recruitment, campaign and issue advocacy programs, meeting planning, literacy and armed services initiatives, leadership development, community service, and more.
- Campaign Management Schools, Legislative Day at the U.S. Capitol, and other programs, workshops and seminars that offer members the opportunity to meet national Republican leaders, discuss key issues, and develop leadership and professional skills.
- Networking opportunities and the ability to meet and develop relationships with women from across the country through online discussion forums and national events such as the biennial convention and annual board meetings. NFRW's national events include interactive workshops, exciting speakers, and informative programs and discussions.
- Representation in Washington, D.C., including the services of a professional staff and maintenance of NFRW headquarters located in Alexandria, Virginia, a few miles from Capitol Hill.



# The National Federation of Republican Women Stands for Election Integrity: Voter ID, Verified Registration, & Ballot Security

Safeguarding the election process from fraud is essential to preserving our democratic republic. Across the U.S., honest citizens want honest elections. Preventing election fraud requires voters be U.S. citizens – verifiable by free voter IDs and a verifiable pre-Election Day registration process. Elections must remain under the watchful administration of state and local elected officials, not run by federal bureaucrats.

KEEP Voter Eligibility, Verifiable Voter Registration, and Voting Safeguards. STOP the Floodgate to Voter Fraud. STOP H.R. 1/S. 1.

The NFRW is putting its grass-roots efforts behind stopping H.R.1/S. 1 - 117th Congress (2021-2022). The "For the People Act of 2021" is actually a massive assemblage of new federal laws and rules to take control of elections away from locally elected officials who are accountable to their local voters.

As passed by the House, the proposed Act would eliminate verifiable voter registration processes, ban requiring Voter ID, and replace secure Election Day ballot-casting with an unsecured ballot-casting season. H.R. 1 would allow anyone who steals an identity to show up and vote without any way to verify or challenge the voter's identity or eligibility to vote. H.R. 1 would allow anyone to mail a ballot and anyone to collect ballots with no way to verify who actually voted or the number of times he or she voted.

**Voter fraud will be rampant if H.R. 1 becomes law.** The bill's very name is deceptive; its many provisions legalize dishonest voting practices and are an affront to honest U.S. citizens. These include: automatic voter registration, online voter registration, and same-day registration — all wrong because there is no way to verify eligibility or identity. The new rules also would allow unrestricted early voting, no-reason absentee balloting, and ballot-collecting by anyone — all wrong because Election Day becomes a 15-Day Election where anyone, including felons, illegal inhabitants, and identity thieves, can mark a paper ballot anywhere to be collected by anyone without any way to verify who voted or how often.






