# The 9th Amendment Rights Retained by the People



**The enumeration in the Constitution, of certain rights, shall not be construed to deny or disparage others retained by the people.**

It is useful to note a distinction between what the amendment says explicitly and what might be implied by or inferred from its reference to other rights “retained by the people.” When read literally, the only thing the Ninth Amendment does is state a rule about how other provisions in the Constitution should be read. The Ninth Amendment thus stands as one of only a handful of provisions (see Article IV, Section 3, Clause 2), that speak to how the Constitution itself should be interpreted. The Ninth Amendment’s explicit command does not directly confer rights or limit the scope of federal powers. *Rather, the Amendment simply instructs interpreters to reject arguments that seek to use the existence of particular enumerated rights in the Constitution to “deny or disparage” other “retained” rights.*<sup>1</sup>

Randy Barnett argues that the Ninth Amendment’s reference to “retained” rights refers to unenumerated individual rights and that the amendment should be construed to empower courts to enforce such rights directly in the same manner as enumerated rights. But unlike those nonoriginalists who view the Amendment as an open-ended invitation for judges to protect only those unenumerated rights they find appealing, Barnett argues that the amendment’s retained rights language points to a historically defined standard. **According to Barnett, the “retained” rights to which the Ninth Amendment refers are individual natural rights that individuals possessed before the Constitution’s adoption** and that they “retained” to themselves upon forming their government. Barnett draws support for this interpretation from a variety of sources, including the natural rights language contained in Roger Sherman’s draft bill of rights, early American legal treatises, and Madison’s public statements regarding the amendment, as well as Madison’s private, handwritten notes for his bill of rights speech. Barnett contends that the “retained” natural rights to which the amendment refers may be protected by adopting a judicially enforced “presumption of liberty” that would require the federal government to demonstrate that its regulations are truly necessary to protect the liberties of others and not merely a pretense to impose undue burdens on the rightful exercise of natural rights by individuals.

So, of the arguments for natural rights possessed before the Constitution, where might they be found? The Constitution wraps right back to the original document that formed this country: The Declaration of Independence!

When in the Course of human events, it becomes necessary for one people to dissolve the political bands which have connected them with another, **and to assume among the powers of the earth, the separate and equal station to which the Laws of Nature and of Nature’s God entitle them.** a decent respect to the opinions of mankind requires that they should declare the causes which impel them to the separation.

**We hold these truths to be self-evident, that all men are created equal, that they are endowed by their Creator with certain unalienable Rights, that among these are Life, Liberty and the pursuit of Happiness. --That to secure these rights, Governments are Instituted among Men, deriving their just powers from the consent of the governed.**<sup>3</sup>

Liberty is the key to a limited federal government. not a national government.

But our government has become an out-of-control behemoth that is no longer deriving its “just powers from the consent of the governed! We are at a Constitutional crisis because the Despots (the Democrats) have attached the Constitution by increasing restrictions to our liberties from all angles.

As Mark Levin points out in his book *The Liberty Amendments*: That the federal government has become the nation’s largest creditor, debtor, lender, employer, consumer, contractor, grantor, property owner, tenant, insurer, health-care provider. . . It regulates your baby’s toys, crib, and stroller; plans your children’s school curriculum and lunch menu; and administers their student loans in college. **THIS IS NOT THE ORIGINAL INTENT OF THE ORIGINAL CONSTITUTION!**

If this 247-year-old Constitutional Republic is to survive, we must turn the tides of time, and take back the 9th Amendment to it its original intent! Not an overnight project, but an undertaking to keep our country!

Where to start? Receiving this letter is a good start. Second, support a candidate through action(s). Third, the party itself needs to get organized to its peak performance level, and not have infighting. The Constitution was written in 116 days: no cell phones, internet, or out of control media, just steadily working. Politics is never easy, but if your posterity is to have a better tomorrow, you have to fight the battle today.

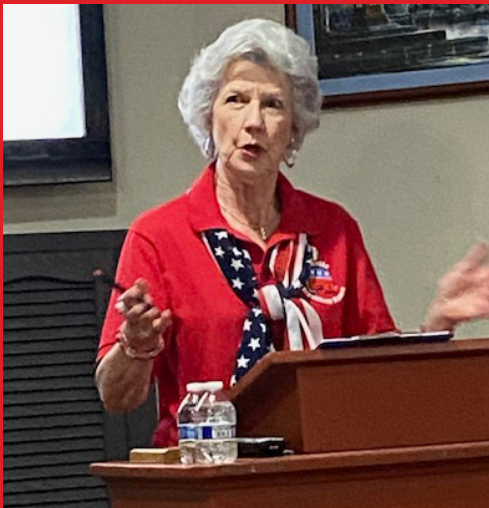

## **GOP CAUCUSES ARE SET FOR 2/8/24**

**ALL EYES WILL BE ON NEVADA** when Republicans caucus on **February 8, 2024**. Currently, the Silver State will be the “**First in the West**” and third in the nation to weigh in on the presidential contest.

The caucuses are the first step on the path to the 2024 Republican National Convention, July 15-18, 2024, where our Presidential nominee will be chosen. Caucuses provide an opportunity for every registered GOP voter to help elect a conservative president in 2024.

**The debate about whether we should have a primary or caucus has ended.** The decision has been made. We are having caucuses. Unlike the primary, they will produce official, binding results that will determine which candidate gets the votes of Nevada’s delegates at the Republican National Convention.

In Nevada, there is a long tradition of presidential caucuses. Caucuses build enthusiasm, encourage participation, and are open to all registered Republicans. Voting is conducted in person and people are required to show government-issued identification. The process is much safer and more secure than when mail ballots or voting machines are used.

**Caucuses will be held in locations around the state.** The meetings include presentations by supporters of each candidate, followed by discussion, and a presidential preference poll. The votes will be cast on paper, counted openly, and the results announced that night.

Even though we will have caucuses, state law requires that Nevada also have a primary. The cost of the primary is

borne by the state, with your tax dollars — estimated to be \$5 million. However, in a caucus, candidates pay the expenses; there is no cost to taxpayers or the Party.

**The primary will have no official role in selecting our candidate. Party rules specify that candidates cannot take part in both the primary\* and the caucuses.** The bottom line: if a candidate wants to get delegates from Nevada, they must take part in the caucuses.

During the 2021 legislative session, the *Democratic-controlled legislature passed a law requiring presidential primaries, even though the Party did not ask for it.* It interferes

with the ability of the GOP to determine its own method of selecting delegates and creates confusion among voters. Once again, the Democrats are more interested in playing partisan politics than in serving the people of Nevada or burdening taxpayers with the \$5 million cost of a non-binding election.

Absentee ballots for the caucuses will be available for active-duty military members and their dependents. Everyone else must vote in person. Precinct locations will be published no later than November 30, 2023, on the state GOP website. All caucuses will start at 5 PM.

**Mark your calendar now for February 8, 2024.** Nevada will be one of the first states to make a difference in the 2024 campaign!

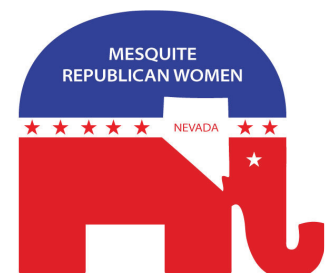

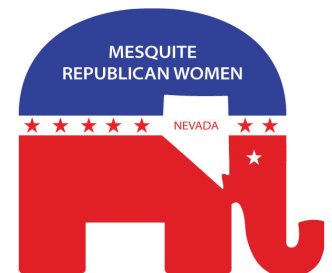
